Item 1 - Previous Meeting Minutes

Item 2 - Move of training establishment from Bordon to Lyneham

Members were told that the move of Army training is expected to be Sept 2015. RAF armourers have been attending courses at Bordon, but only for specific weapon types. RAF Regiment armourers do have the same type of training, but the RAF have their own association which is much larger than our own. It was felt that if we were to allow membership we could be swamped by the numbers. The suggestion was put forward that an affiliation may be a way forward and the committee were asked to look into this and report back to the membership.

Item 3 - Dinner Venue

The Secretary read out the results of the survey for the preferred location from members both by email and post.

Birmingham 8.5%
Leeds 5.7%
Nottingham 7.0%
London 56.3%
Other 15.5%

There were 48 respondents by email and 18 by post, giving a total of 66. This out of a total of 389 active members. The figures should therefore be taken as a rough guide only.

The Chairman shared with members the results of his enquiries to the Royal Armouries in Leeds. They have several rooms for hire and a range of dinner menus', they can also arrange cheaper accommodation for block bookings.



The cost of room hire was queried and the Chairman took the action to clarify the costs. It was also stated that members may wish to make a weekend of the trip with visits to the weapons rooms and also the pattern room.

The discussions concluded that we must attempt to provide those living further North of London the opportunity attend an Association Dinner. The majority of members attending the AGM indicated that they would be willing to travel for the next dinner. It was proposed that the annual dinner for 2015 be held at Leeds and the following year to revert to London. If successful the pattern will be repeated.
